Request for progress updates on collection of the Vacant Site Levy for 2018-2024

In order to provide the Department with an update on progress on the implementation and collection of the vacant site levy on a national basis, planning authorities are hereby requested to arrange for the completion and signing of the **Vacant Site Levy - Progress Report 2025** (template attached at Appendix 1).

In order to enhance the levy collection rate or influence activation of development on relevant sites, local authorities should, in addition to issuing the standard levy demand notice each year, subsequently issue reminder notices and, as appropriate, institute debt recovery procedures in respect of outstanding levies due, including in respect of previous years. All such communications to site owners should indicate that under section 19 of the Urban Regeneration and Housing Act 2015, unpaid levies due remain a charge on the land in question until they are paid.

The completed progress report should be returned to planningperformance@housing.gov.ie by Friday 21 November 2025.
